



## 11 YEARS TREND

Rotary 4

- 2005 to 2016 9 Clubs were Chartered
- In the same years 12 Clubs were Terminated
- Currently we are at net -3 clubs
- Between RY2005-2006 to RY2010-11 we lost 8 clubs and net loss -138 members
- Positive is, in 11 years, Membership increased by net +160 (1848 to 2008)

# Message to take

- We must charter new clubs including Satellite Clubs if we want to increase our membership <u>significantly</u>
- Statistically over the 11 years its proven that organic growth will not give more than net +50 members
- Highest in the last 11 years was +80 (RY2014-15)
- Average last 3 years was +42

- An area in your district doesn't have a Rotary Club
- Your Rotary Club can no longer accommodate new members

### 9 STEPS TO START A NEW ROTARY CLUB

- 1. Determine Areas for New Club
- 2. Develop Your Strategy
- 3. Create a Marketing Plan
- 4. Hold Informational Meetings
- 5. Recruit Charter Members
- 6. Hold Organizational Meetings
- 7. Complete New Club Application
- 8. Celebrate Charter Approval and Publicize Club
- 9. Continue Mentoring New Club

# SATELLITE CLUB

If you have intention to form a new club but do not have 20 charter members yet, start with a Satellite Club

# INTRODUCTION & HISTORY

- Following the COL in 2013 a Rotary club is now able to establish its own Satellite Club.
- There is no limit on the number or type of Satellite Clubs that may be formed by the Sponsor or Host Club.



# INTRODUCTION & HISTORY

- Satellite Clubs (SC) are an extension of the Sponsor Club and offer an alternative meeting time and place to the Sponsor Club.
- A member of the Satellite club is a member of the Sponsor Club and subject to the same rules as any other member.



# Satellite Club Strategy

- Viewed tactically, starting a new SC can be viewed as a first step towards starting a new Rotary Club
- Viewed strategically, SC can be used to address a wide variety of needs from penetrating under served market niches to addressing issues related to outdated RC culture. In some places, full blown club make sense; in other places SC are the perfect answer



# Purpose

- Take the first step in chartering a new club
- Accommodate rural and remote areas or communities with small populations
- Accommodate large metropolitan area in allowing one club to provide several meeting times and locations



# Purpose

Rotary

- Provide an opportunity for a small, weak or struggling club to become connected to a larger, active club for ongoing mentoring, support and assistance
- Accommodate different demographic groups such as young people where the established Rotary Club doesn't suit them or isn't attractive to them

# Starting a Satellite Club

### Advantages in joining SC:

- No time-consuming wait for Charter, get straight down to business
- Administration, membership, club financials, SAR's etc. are the responsibility of the Sponsor Club
- The SC starts with a blank sheet and can build its own priorities and traditions over time



#### How are satellite clubs named?

Satellite clubs have the same name as the sponsor club plus a qualifier that distinguishes it from the sponsor, for example:

Sponsor and satellite clubs have different meeting locations

Sponsor: Rotary Club of Tanglin

Satellite: Rotary Satellite Club of Tanglin **Downtown**

#### WHAT YOU'LL NEED TO START

- Starting a new club brings together community and thought leaders to discuss ideas and take action to meet community needs.
- Governors often appoint a GSR and collaborate with their assigned club and District Support team during the process.



#### A NEW ROTARY CLUB:

- GSR. Typically, the governor appoints a new GSR or works with the district's new club development committee.
- What makes the difference? Commitment and experience. The new GSR champions the effort from start to finish. And the adviser's involvement after the charter is critical to the club's success in its first years of operations.

### A NEW ROTARY CLUB (cont):

- Sponsor club. Having a sponsor is strongly recommended but isn't required.
- What makes the difference? The success rate of new clubs can be improved by as much as 10 percent with the support of a designated sponsor club.
- At least 20 charter members. The minimum number of charter members is 20. District prefers 25.

### A SATELLITE CLUB:

- Sponsor club
- At least eight members
- A completed satellite club application form
